

Memorandum of Understanding for Academic Cooperation

Department of Economics, Borholla College, Jorhat(Assam) PIN-785631 and Department of Economics, Cinnamara College, Cinnamara, Jorhat (Assam), PIN-785008, recognize their strength in education and co-curricular activities, and their mutual interest in engaging themselves in academic cooperation.

Department of Economics, Borholla College, Jorhat(Assam) and Department of Economics, Cinnamara College, Cinnamara, Jorhat (Assam), therefore, agree to establish programmes of academic cooperation in the areas of mutual interest, in accordance with terms and conditions set forth in this memorandum of understanding (MOU).

Objectives:

The goal is to foster collaboration, provide opportunity for regional experience, and to facilitate advancement of knowledge on the basis of reciprocity, best efforts, mutual benefit and frequent interactions. Department of Economics, Borholla College and Department of economics, Cinnamara College, Cinnamara, agree:

- a) To exchange information on education programmes.
- b) To exchange information on teaching, learning materials and other literature relevant to their educational programmes.
- c) To jointly organize short short-term continuing education programmes on topics of mutual interest and invite each other's faculty to participate there in.
- d) To jointly organize seminars, conference or workshops on topics of mutual interest and to invite each other's faculty to participate there in.
- e) To exchange, on a reciprocal basis, students at undergraduate honours course for limited periods of time for purpose of education.

Department of Economics, Borholla College, Jorhat(Assam) and Department of Economics, Cinnamara College, further agree that detailed terms and conditions that guide each activity identified above will be separately determined and agreed upon by the two departments of the institutions.

EXCHANGE OF FACULTY

Department of Economics, Borholla College, Jorhat(Assam) and Department of Economics , Cinnamara College, agree to encourage collaboration between faculty from Economics Departments of the two institutions. Specifically, Departments will encourage members of their facilities to undertake classes at each other's institutions as per the existing norms, terms and conditions.

JOINT CONFERENCES AND WORKSHOPS:

Department of Economics, Borholla College, Jorhat(Assam) and Department of Economics, Cinnamara College, agree to help identify and invite faculty members from the other institutions to participate in conferences and workshops. The terms and conditions for such participation will be mutually worked out by both the departments.


CO-ORDINATION

Each department shall appoint one member of each teaching staff to co-ordinate the programme on its behalf.


TENURE AND TERMINATION:
