Then the participant members give their respective views and finally comes to the following resolution.



aware the students regarding anti-ragging. So to discuss the matter, the sitting is convened. The participant members give their views on this matter and finally comes to the following resolution.




The anti-ragging committee should take some resolution regarding anti-ragging.






